E - Notes to the condensed interim consolidated financial statements

1) General information

The financial statements were signed off by the Board of Directors on September 25, 2024.

Guillemot Corporation designs and manufactures interactive entertainment hardware and accessories. The Group offers a diversified range of products under the Hercules and Thrustmaster brands. Active in this market since 1984, the Guillemot Corporation Group currently operates in 11 countries – France, Germany, Spain, the United Kingdom, the United States, Canada, Italy, Belgium, the Netherlands, Romania and China (Shanghai, Shenzhen and Hong Kong) – and distributes its products in more than 150 countries worldwide. The Group's mission is to offer high-performance, user-friendly products that maximize enjoyment for end users of digital interactive entertainment solutions.

Guillemot Corporation is a publicly traded company (société anonyme) headquartered at 2 Rue du Chêne Héleuc, 56910 Carentoir, France.

2) Basis of preparation of condensed interim financial reporting

This set of condensed interim consolidated financial statements to June 30, 2024 has been prepared in accordance with IAS 34, "Interim financial reporting". The condensed interim report should be read in conjunction with the 2023 annual financial statements.

3) Accounting policies

The accounting policies employed are the same as those used in preparing the annual financial statements for the year ended December 31, 2023, as set out in the annual financial statements for the year ended December 31, 2023.

Amendments to IAS 1, "Classification of Liabilities as current or non-current" and "Non-current liabilities with covenants", IAS 7 and IFRS 7, "Supplier Finance Arrangements", and IFRS 16, "Lease liability in a sale and leaseback", applicable with effect from January 1, 2024, had no material impact.

4) Business review

Business activity and results

In the first half of 2024, the Group's turnover grew 16% to €56 million in a relatively calm market.

Net operating income in the six months ended June 30, 2024 came in at €3.6 million, compared with a €3.9 million net operating loss for the same period in 2023. This performance was helped by an improvement in the accounting gross profit margin, which came out at 56%, close to its 2022 level, compared with 45% in the first half of 2023.

Total costs (total operating expenses excluding purchases and changes in inventories) increased by 8%, while turnover was up 16%.

The net financial expense of €0.3 million included a €1.2 million unrealized loss arising from the decline in the valuation of the portfolio of Ubisoft Entertainment S.A. shares. Consolidated net income came in at €2.5 million.

Shareholders' equity stood at €102.7 million at June 30, 2024. The Group's net debt was negative at - €19.6 million excluding investment securities, the fair value of which was €9.1 million at June 30, 2024. Following the recent fall in the price of Ubisoft Entertainment shares, the value of the portfolio stood at €5.3 million at September 24, 2024.

The value of net inventories stood at €44.3 million at June 30, 2024, down 3% from December 31, 2023, in anticipation of requirements in the run-up to the end of the year. Working capital decreased by €2.6 million over the first half of the year.

Net capitalized research and development costs increased by €0.6 million over the six months to June 30, 2024, to end the period at €11.1 million in net value.

Thrustmaster news

On September 19, 2024, Thrustmaster entered into a strategic sales agreement with JD.com, China's leading e-commerce operator and one of the brand's main Chinese distribution channels. This three-year strategic deal, signed at JD's headquarters in Beijing, will considerably boost Thrustmaster's influence and leadership in China and ensure that the brand's high-quality next-generation racing wheels, gamepads and joysticks will be more widely available to Chinese consumers.

Racing: Thrustmaster is working towards launching new racing products that will expand the brand's presence in brick-and-mortar stores in the United States and Europe. On August 22, 2024,

Thrustmaster unveiled its new upgradeable pedal set, Raceline Pedals LTE (Long Term Evolution). Equipped with two metal pedals with a sandblasted finish, this fully adjustable pedal set is powered by HEART magnetic technology for exceptional precision and maximum durability. The EVO RACING 32R LEATHER racing wheel continues to be stocked by more and more retailers internationally.

Thrustmaster will also be launching its brand-new Direct Drive racing wheel, which will serve as a gateway to "discovering the next generation of sim racing technology". The new wheel received a very enthusiastic response from journalists and customers who were given the opportunity to blind test it at Gamescom in August, and experience its subtle yet accurate rendering of game effects.

Flight sim: Microsoft Flight Simulator 2024, due to be released on November 19, should drive increased sales for Thrustmaster, enabling the brand to consolidate its position as the number one maker of flight sim accessories thanks to the partnership that will be put in place around this new product. Meanwhile, the launch of AVAF/A-18 Super Hornet Flightstick in the third quarter will further strengthen the range's ecosystem.

Hercules news:

The DJing range continues to be stocked by more and more retailers and has garnered positive feedback in the trade press and on social media. A video posted by two young French YouTubers, Mathis and Gauthier, on September 17 described the *Hercules Stream 100* mass-market audio controller and *Hercules Stream 200 XLR*, more geared towards professional streamers and gamers, as "revolutionary" and "very well made". Hercules is also working on new bundles that will add turnkey solutions for all streamers, whether beginners or advanced users, to the *Hercules Stream* range.

Outlook

The Group is set to launch a number of major new products in the fourth quarter of 2024, and will be leveraging both the new 2024 version of the game *Microsoft Flight Simulator* and its partnerships to increase its market share.

The Group maintains its forecast of sales growth and a net operating profit for fiscal 2024.

Brands

Brands include the acquired brands Thrustmaster and Hercules. These brands are tested for impairment at the end of each fiscal year and are measured taking into account discounted future cash flows. Brands are also tested for impairment whenever there is an indicator of impairment.

Value in use is the present value of future cash flows expected from an asset – i.e. from its continuing use and removal at the end of its useful life. In the absence of a deep market, this is the method used to measure the Group's brands.

• Hercules

The Hercules brand is allocated to the Hercules cash-generating unit (CGU).

The Hercules brand has a net balance sheet value of €432k, compared with a purchase cost of €1,432k.

There were no indicators of impairment at June 30, 2024, and no updated impairment test has been carried out since that date.

Measurement of the Hercules brand is subject to adjustment in future years should assumptions concerning future cash flows generated by the Hercules business be downgraded.

• Thrustmaster

The Thrustmaster brand is allocated to the Thrustmaster CGU.

The Thrustmaster brand has a net balance sheet value of €9,410k, the same as its purchase cost.

Measurement of the Thrustmaster brand is subject to adjustment in future years should assumptions concerning future cash flows generated by the Thrustmaster business be significantly downgraded.

Thrustmaster has achieved global recognition and is now a key player in PC and console racing wheels and joysticks, with an installed base that continues to grow.

At June 30, 2024, there were no indicators of impairment suggesting that an updated impairment test needed to be carried out.

Development costs

Development costs on projects meeting the six eligibility criteria laid down in IAS 38 are capitalized.

Assets are transferred from assets under construction to capitalized development costs when released into production. The net value of development costs capitalized over the period totaled €603k.

The €428k decrease in assets under construction is mainly the result of the transfer of €354k of assets to development costs.

The following Guillemot Corporation Group companies incur development costs: Hercules Thrustmaster SAS, Guillemot Innovation Labs SAS, Guillemot R&D Inc., Guillemot Romania Srl and Guillemot Corporation (HK) Limited. Capitalized costs concern all Hercules and Thrustmaster product lines.

Licenses

The €353k increase in this item is the result of the recognition in the balance sheet of new minimum warranties, with no impact on the 2024 cash position.

The €1,555k decrease in assets under construction corresponds to transfers of assets to the "Buildings" and "Plant" items.

The increase in the "Buildings" item is mainly the result of the entry into service of a photovoltaic system (€498k) and the purchase of a wood-fired furnace (€796k), both at the Carentoir site. These investments were made as part of the Group's corporate social responsibility efforts.

This item is also affected by the €1,921k increase in the valuation of IFRS 16 right-of-use assets.

The value of the lease covering the premises in Rennes was re-estimated following a change in the lease term, resulting in a €1,618k increase in the value of the associated right-of-use asset.

Adoption of IFRS 16 resulted in a €4,605k increase in net property, plant and equipment at June 30, 2024 in respect of lease right-of-use assets (€4,435k in buildings and €170k in other property, plant and equipment).

Tangible fixed assets under construction mainly consist of molds and tools used in the production of new products.

Financial risk

In accordance with IFRS 7 on financial instruments, a breakdown of the Group's exposure to the various types of financial risk is as follows.

<u>Liquidity risk</u>: At June 30, 2024, the Group's borrowing and bank financing facilities were not fully utilized and net debt was negative at -€19.6 million. At June 30, 2024, the fair value of the Group's portfolio of investment securities stood at €9.1 million.

At September 24, 2024, the price of Ubisoft Entertainment shares had fallen 41% since June 30, 2024, reducing the portfolio's fair value by €3.8 million.

Equity risk: The Group's earnings are affected by fluctuations in the market price of its shareholdings. The 41% fall in the price of Ubisoft Entertainment shares between June 30 and September 24, 2024 reduced net financial income by €3.8 million.

<u>Interest rate risk</u>: Based on the Group's outstanding floating-rate financial liabilities at June 30, 2024, a 1% annual increase in interest rates would have no impact on net financial income.

Based on foreign currency values exposed to exchange rate fluctuations at June 30, 2024, a 10% annual increase in US dollar exchange rates would increase financial expenses by €558k.

Based on foreign currency values exposed to exchange rate fluctuations at June 30, 2024, a 10% annual increase in the value of sterling would increase financial expenses by €124k.

Since all major players in the multimedia industry transact in US dollars, no one manufacturer has a competitive advantage that would result in increased market share. Since all industry players index-link their selling prices to cost prices in US dollars, selling prices rise and fall in line with cost prices.

The main currency for purchases of hardware and accessories is the US dollar. The dollar is also the trading currency in the United States, Canada and all other countries outside Europe. In Europe, the Group mainly sells its products in euros. Rapid currency fluctuations, and in particular declines in the value of the US dollar, may result in lower selling prices for the Group's products, thus impacting the value of inventories. Conversely, given seasonal variations in the Company's business, if the US dollar were to rise sharply during the second half of the year, the Group would not be able to adjust its selling prices to reflect the full extent of such an increase, which could therefore temporarily affect the Group's gross margin.

However, to limit the Group's foreign exchange risk, Guillemot Corporation hedges against currency fluctuations by buying spot currency and currency futures and options.

Furthermore, the increased level of export sales has boosted the Group's natural hedging and significantly reduced its foreign exchange risk.

There were no currency futures or options outstanding at June 30, 2024.

<u>Credit risk</u>: Credit risk is the risk of financial loss should a customer fail to meet its contractual obligations. The Group manages this risk by taking out credit insurance covering more than 80% of the overall risk while deliberately excluding some accounts associated with the Group's top customer (for an amount equivalent to 14% of consolidated turnover) in light of the strength of that customer's financial position. Since the Group uses wholesalers, it has a limited number of customers. In a few cases, the Group is obliged to grant additional credit where its insurance cover is considered clearly unsuitable.

<u>Risk associated with protectionism</u>: The Group's products are currently traded all over the world and are subject to moderate customs duties. Protectionist policies could result in high customs duties, adversely affecting the Group's sales in affected countries.

25) Seasonality

As a rule, the Guillemot Corporation Group generates around 50% of its annual turnover between September and December. The Group uses subcontractors to meet increased production and logistics requirements during this period. The working capital requirement arising from these seasonal variations is financed through short- and medium-term funding.

26) Subsequent events

The price of Ubisoft Entertainment shares fell by 41% between June 30 and September 24, 2024, reducing the Group's net financial income by €3.8 million.
